



## Vista Palomar Riders Facility Use/Membership Agreement

In order to use the VPR Club facilities you must be a member in good standing.  
Our insurance allows for NO EXCEPTIONS.

*As a member, you agree to the following:*

1. Junior Members (under 18 yrs. old) on VPR grounds must be supervised by a VPR adult member at all times.
2. Members must stay on site when horses are stalled.
3. Dogs are NOT PERMITTED on VPR property at any time due to new insurance guidelines. If you bring your dog, you will be asked to vacate the premises.
4. Trainers may not conduct individual or group lessons on VPR grounds, even if you are a member.
5. If you use a stall, haul manure to the manure pile next to the garage. Close stall gate before you leave. Any equipment used should be put back where it was found and nothing should be left in arenas. Do not throw manure in creek. **LEAVE IT IN BETTER CONDITION THEN YOU FOUND IT!!!**
6. Combination locks are periodically changed to ensure that only VPR members have access to our facility therefore do **NOT** give combination to non-members.
7. If you see a hazard or something broken, if possible, fix it or notify a VPR Board Member – names are posted at announcer's booth.
8. If an accident, injury or property damage occurs, accident-injury reports are available in front of the announcer's booth. **Fill out and call a Board Member.**
9. Periodically our arenas are prepared in advance for a show and then locked to keep it maintained until show day. If this occurs, it will be posted on the website. Otherwise; the arenas will be unlocked and available to you.
10. NO TURN-OUT OR LUNGING IN SHOW OR WARM UP ARENAS. Use the round pens for lunging and turn out.
11. **During the rainy season, grounds may be closed 2 to 4 days following a rain.** Use common sense – the grounds need to dry out to avoid injury to you & your horse and to prevent damage to the arenas. Check our website and Facebook for arena closures and conditions. **It is always your responsibility to check the footing before you enter the Arena.**
12. The arenas will be groomed every Friday and Monday weather permitting. **Do not move the hose or sprinklers** as they are set-up on timers in preparation for watering during the night. Do not enter the arenas if the Sprinklers are set out. Do not turn on the water in the arenas.
13. The River Trail is private property owned by the State and Vessels Ranch so **use it at your own risk.**
14. You must have board permission to stay on the grounds overnight or to leave trailers/vehicles overnight.
15. No ATV's or similar vehicles on grounds (insurance requirement).
16. Comply with VPR Club policies and By-Laws.
17. Announcements are located on the Bulletin Board on patio.
18. Always bring a cell phone to the grounds in case of an emergency.
19. **The gates and club house must be locked and lights turned off when the last member leaves the grounds. (check 2x's please!)**
20. **Always check the club calendar at [www.vistapalomarriders.com](http://www.vistapalomarriders.com) prior to planning a ride or an activity at the club to check availability as we would hate to have you make a trip to the club to find that you can't ride.**
